SELECTION PROCEDURE OF CONTENTS FOR THE Festivaliño on the road 2023

1. O SUBMARINO 2023. FACE A. MAIN HALL

O Submarino 2023 is a screening room in a traveling caravan where audiovisual contents for children are shown. Its journey started in May 2009 and since then, it has continued to visit the towns and cities in the northwest of the Iberian Peninsula. It offers a new exhibition venue for this kind of contents, that is surprising and appealing for kids up to 12 years old. More than 100,000 spectators have passed through this traveling exhibition hall since 2009.

2. CINE NA RÚA 2023. FACE B. OTHER HALLS

Regular programming of outdoor cinema (summer cinema) that takes place in different locations in summer 2023 in Galicia. One of the shorts selected by the *Festivaliño* on the road 2023 will be programmed before each screening of the family cinema.

These rules set up the official call for entries for the 2023 catalogue by *Festivaliño* on the road 2023. Among 20 and 30 pieces will be part of this selection.

3. SUBMISSION REQUIREMENTS

- This contest is open to all audiovisual contents for children which do not exceed 20 minutes in length.

- Films must have been completed after the January 1, 2022.

- The selection criteria will focus on quality, originality and didactic and entertainment values.

- Will be presented in original version. All non-Spanish or non-Galician language films must have Spanish or Galician subtitles or attach a list of dialogues with timecode in SRT, SSA or SST (in English/Spanish).

4. REGISTRATION

To register is necessary to send:

TELEMATIC REGISTRATION (Preferential)

- Participants must cover the file (registration: see <u>www.festivalino.com</u>). Send a **link to view the short film** with your password (if necessary) and **attach a technical and artistic record** where it appears: contact data, nationality, synopsis, as well as artistic and technical data. In addition to **3 images** in PNG or JPG format.

5. SELECTION

A selection committee appointed by the organization will select those that will be part of the 2023 catalogue. The composition of this committee will be published when reaching the deadline through the site: <u>www.festivalino.com</u>. Committee decisions will be final. Once the process is finished, the selection will be notified to participants.

The calendar of screenings will be available on the web site <u>www.festivalino.com</u>.

Selected works will be shown every time *Festivaliño* on the road 2023 is programmed.

6. PRIZES AND COMPENSATION

The short film selected will receive royalties of €100.00 per film, and they will opt for:

- Award of adult public (moms and dads) of €1,000.00 euros and trophy.

- Award of children public (children) of €1,000.00 euros and trophy.

Both, kids and adults, will vote every film they watch, establishing a ranking among all those belonging to the catalogue. Those who achieve a higher score will receive prizes in each of the categories at the end of the season.

The settlement will be made during the last 3 months of the year, after the issuing of the bill and according to the current tax regulations.

7. DEADLINE

Submission packages must be sent by the 30th April 2023.

8. GENERAL RULES

1. The organization assumes that the sender of the films (person or production company) has got all the exhibition rights of the short film, as well as the authorization to receive monetary consideration for royalties.

2. Cost for sending materials will depend on the sender.

3. The organization will not return the materials submitted.

4. The organization may use materials (photo, synopsis...) and excerpts, with a maximum length of 2 minutes, for promotional and information purposes.

5. The organization will publicize the contents that are part of the catalogue of the *Festivaliño* on the road 2023, through its website and social networks and with a printed billboard present in the venue where the *Festivaliño* on the road 2023 is located.

6. Participation in this process implies the acceptance of these rules and regulations and the solutions given by the organization to any problem not included in them.

7. These rules are edited in Spanish, English and Galician. If any doubt in interpretation, the Galician version will be considered valid.

8. The organization will not take any responsibility for any infringements of these rules.
